The greatest number awarded are non-competitive advised, whereby grant investments are advised by donors. Other grants, those where prospective grantees submit proposals for review, are made to numerous organizations in Northeast Florida: with primary emphasis given to supporting public education reform; nonprofit capacity building; strengthening neighborhoods; improving the quality of life for aging adults; the arts; women and girls; infants and young children; early literacy; diversity and inclusion. The Foundation also serves as a civic leader, using its local knowledge, networks, influence and creativity to bring people together in ways that will improve the community's quality of life today and in the future.
