He embraced causes such as the Jewish Community Alliance, for which he established an endowment at The Community Foundation, along with Greenwood School and The Arc Jacksonville, which are also endowed thanks to his generosity. To memorialize his legacy, some of his closest friends and fellow philanthropists shared their remembrances of David.

#### Wayne Weaver, Friend & Philanthropist

David Stein's philanthropic approach came from his love of community and his lively personality. He not only gave funds to a large number of nonprofits, but he was also personally involved with the recipients and organizations he cared so much about.

#### Gary Chartrand, Friend & Philanthropist

David Stein invested in causes he believed in, but most importantly, he invested in the people that were responsible for executing the plan.

We were having lunch after a round of golf one day and got talking about education reform. We agreed to partner on a project, and we raised about \$40M for the Quality Education for All Fund at The Community Foundation. We worked with Superintendent Dr. Nikkolai Vitti and Duval County Public Schools on several initiatives to improve education.

The community is so much better off because David's philosophy was to give back to the community where he made his money. That's what he did!

#### Cindy Edelman, Friend & Philanthropist

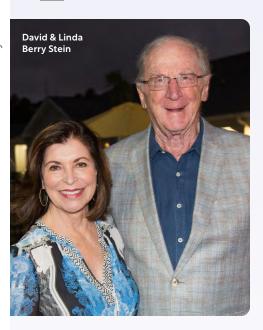

I moved here as Bob Shircliff's partner at just 33 years old and I didn't know anyone. David was a legend to me. He called me up one day and invited me to lunch in the Gulf Life building. He was so supportive of me as a new young person in the community, and very encouraging. No one was more joyful giving their money away than David. The example set by his parents, who founded River Garden, filtered down to him and he lived by the Jewish principle of Tikkun Olam, to repair the world. To David, giving back and leading others to charity was its own mitzvah. He was a happy giver. In fact, he was gleeful about it. If you thought he might be asking you for too much money he would say, brushing his shoulder, 'it's just dandruff.'

## CONNECTING ACROSS DIFFERENCES, in Divided Times





- Q: How did you become interested in differences, disagreement and pluralism?
- A: In some ways, I think my entire life has been preparation for working across disagreement. I'm half Japanese, but grew up in largely white cultures. I went to Duke and then UNC Chapel Hill, where I was an extreme minority. I was in the military, but also influenced by a pacifist theologian. As a lawyer, I believe that legal training is a great way to understand difference, to understand the other side at its best, rather than at its worst.
- Q: You use the words "PLURALISM" and "CONFIDENT PLURALISM" frequently. What do these terms mean?
- A: It's just a fact of the world that we have lots of deep differences over things that matter, not just over small things, like ice cream flavors and sports teams, but over fundamental questions like the purpose of a human being or the nature of human flourishing. And when you have those deep differences, this creates the fact of pluralism, and that creates a political problem. How do you live together with people who hold such different views about the nature of reality and the importance of living together in society? When encountering the difference, you could say, "I'm going to try to win at all costs and control," or you could say, "I'm going to leave and be with my people." Or you could say, "I'm going to figure out how to engage across this difference." And that's what I call "confident pluralism."

- Q: At The Community Foundation, we work with donors who have different interests, but a common concern for the local community. How does pluralism connect to this work?
- A: At the local level, especially, it's really important to have institutions and people who can connect and convene in order to pool resources and to activate networks that are required to solve some of society's deepest problems. Your constituents focus on different issues, and some of them, as individuals, will be supporting efforts that are antithetical with one another. But as an institution, you can still name an overlap or a shared consensus. There are enough social problems to tackle at the local level that you should be able to find lots of common ground where you can work together, even across your differences. You don't have to use this institution or these opportunities to work out all of your deepest disagreements. You can say we care about this city, we care about this region, and here are some very practical ways where we can activate networks and resources to get things done.

#### **Surfear Negra**

This Jacksonville-based nonprofit works to "diversify the line-up," bringing girls of color, who are underrepresented in surfing, to discover the joy of the sport. In 2023, Surfear Negra received a \$2,500 small organization grant to support the Summer 2023 "Come to the Water" surf camp for 20 girls.

Surfing is a wonderful sport, and any sport that incorporates nature, whether it's waterways or green spaces, tends to foster healthier people. We want to empower girls to have the opportunity to surf and experience nature.

#### St. Johns Riverkeeper

The Ribault River is a hidden gem in Jacksonville. This tributary of the St. Johns River is located in Northwest Jacksonville, adjacent to Moncrief Creek, and both watersheds have a major impact on the surrounding neighborhoods. This year, St. Johns Riverkeeper received a five-year grant from the Delores Barr Weaver Legacy Funds, providing \$100,000 a year to support projects such as Resilient Ribault project, an initiative with LISC Jacksonville to help people connect to the waterways while also mitigating issues such as flooding.

St. Johns Riverkeeper represents the entire St. Johns River watershed, an area that spans nearly 9,000 square miles. As a result, our resources and staff are often spread thin. The multi-year Weaver grant has given us the opportunity to concentrate more time and resources into a smaller geographic area over an extended period of time. This allows us to build the trust, relationships, and partnerships that are necessary to identify and address the needs of the community and local waterways and work together towards meaningful solutions that will have a lasting impact.

Spectrum Sailing was born out of necessity. Its founder, Scott Herman, was looking for a sailing camp for his son, who is autistic, and couldn't find a program to take him to. Spectrum Sailing recently expanded to Jacksonville, in partnership with the Florida Yacht Club. This year, Spectrum Sailing received a \$2,500 small organization grant to support a spring break sailing program for neurodivergent youth.

Over the past two years, I have seen the impact Spectrum Sailing has had in the local Jacksonville autism community. Our work has touched not only our sailors' lives, but the lives of the

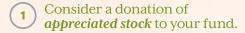

# End of Year Giving

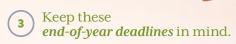
If the cooler temperatures and busy fall event season are any indication, it's that time of year again. The Community Foundation team is standing by to assist you with your year-end charitable giving. Here are three suggestions to make the season smooth and purposeful for you and your family.



Writing a check is an easy way to boost your fund. Giving stock has other advantages. When you give shares of long-term appreciated stock, you can be eligible for a charitable tax deduction at the fair market value of the shares. Then, when The Community Foundation sells the shares and adds the proceeds to your fund, the fund – as part of The Community Foundation, a 501(c)(3) charity – is not hit with capital gains tax. By contrast, if you were to sell those shares and give the proceeds to your fund, you'd have a lot less cash to give to your favorite causes.

### If you can take advantage of the *QCD*, do it.

A Qualified Charitable Distribution ("QCD") is a very smart way to support charitable causes. If you are over the age of 70 ½, you can direct up to \$105,000 from your IRA to certain charities, including a field-of-interest, designated, unrestricted, or scholarship fund at The Community Foundation. If you're subject to the rules for Required Minimum Distributions (RMDs), QCDs count. Through a QCD, you avoid income tax on the funds distributed to charity.



We are ready and available to assist you with your yearend giving needs. Please keep the following dates in mind when planning your 2024 charitable income tax deductions:

- Gifts of complex assets such as real estate, closely held business interests or stock, and planned giving vehicles should be discussed with your relationship manager by Halloween.
- Gifts of mutual funds should be made by December 16, 2024.
- Gifts of appreciated stock should be made by December 23, 2024.
- Donor advised fund grant recommendations should be made in the donor portal, Access My Fund, by December 26, 2024 for grant checks to be postmarked by the end of the year. Timing of grants does not impact charitable income tax donations.

- Wire transfers of cash must be initiated no later than December 30, 2024.
- Checks sent via the U.S. Postal Service to The Community Foundation must be postmarked on or before December 31, 2024.
- Checks sent via carriers such as FedEx, UPS and DHL must be physically received at The Community Foundation on or before December 31, 2024.
- Credit card gifts made by phone must be made no later than 4 p.m. on December 31, 2024; online contributions may be made until midnight.
